NOTICE IN RELATION TO THE COLLECTION, PROCESSING AND USE OF YOUR PERSONAL INFORMATION – THE PERSONAL DATA PROTECTION TERMS

By submitting this application, you are consenting to the collection, processing, use and disclosure of your personal information by the Singapore Shipping Corporation group of companies, which includes Singapore Shipping Corporation Ltd, its subsidiaries and affiliated companies (collectively, the "Singapore Shipping Corporation Group"). The personal information provided by you will be used:

- (a) to assess your suitability for the role that you have applied for or such other roles that the Singapore Shipping Corporation Group may deem appropriate for you taking into consideration your experience, skills and qualifications;
- (b) to carry out any reference checks that the Singapore Shipping Corporation Group deems appropriate;
- (c) if offered the role, to complete your employment within the Singapore Shipping Corporation Group; and
- (d) in the event of your employment, in the management and administration of matters connected with your employment.
